Priority and preference will be given to exhibitors who design new booth spaces and who use professional interior designers/architects for the design of their exhibit space. The name of the firm should be included with the proposed design. Pop up displays and retractable banners are prohibited. Overhead trade banners are prohibited. Suspended installations and lighting are welcome. Please send your booth design to management for approval.

Your booth design must be submitted before your space can be confirmed. Main aisle locations will only be provided to new booth designs.
